

# Parents' Agreement

## Indiana Christian Academy



The mission of Indiana Christian Academy is to love students while challenging them academically in a Christian environment. It is our desire to cooperate with the parents of each student and not to take their place. We understand that we do not have "a corner" on truth nor on the application of truth. It is not our desire to usurp the authority of your home, but we would like to encourage you to have your child(ren) follow the rules and guidelines of ICA while at school and when representing the school.

I have read and understand the Parent/Student Handbook, and I agree to comply with it. I agree that my child and I must support the school's policies, rules, and regulations, including those listed in the Parent/Student Handbook, and I agree to support Indiana Christian Academy with my conduct and my prayers.

I understand and agree that the education of my child will be guided by the instructors and other school officials. I agree that my purpose in obtaining a Christian education for my child will be achieved by following the curriculum and Biblical guidelines set by the school. To that end, I agree that I will require my child to perform all duties and responsibilities entrusted to him/her by the instructors and school officials to the best of his/her ability and to the school's satisfaction. I will support the decisions of the instructors and school officials and will never attempt to undermine their authority (Romans 13:1).

I agree to follow the pattern set up in Matthew 18 regarding any complaints relating to school rules, policies, and disagreements with teacher or staff. If no reconciliation has been met by me and the party involved, I will involve the administration to help resolve the conflict.

I further agree that, should it be necessary to withdraw our child(ren) from school (whether it be by my desire or the school's request), I will cooperate with the administration to make the withdrawal as appropriate as possible, avoiding discussion with those not involved, so as to avert a spirit of dissension and division which would be to the detriment of both child(ren) and school (Ephesians 4:29-32).

**For Kindergarten through 12<sup>th</sup> grade parents:** In placing my student(s) in Indiana Christian Academy, I agree to pay the *registration fee* as indicated on the Financial Fact Sheet 2010-2011. I agree also to pay all *tuition* and *other fees* in a timely manner as set forth on the Financial Fact Sheet each month. If I will be late with a payment or if negative circumstances arise that will affect my ability to make timely payments, I will contact the school office as soon as possible and set up an appointment to meet with the Financial Committee to discuss my situation and develop a mutually agreed upon plan. I further understand that if I fail to make a timely payment (within 45 days of payment due date), my student(s) will be withdrawn from school and that I will be subject to late payment fees and other costs, including any necessary costs of collection in accordance with school policy.

**For preschool parents:** In placing my student(s) in Indiana Christian Academy, I agree to pay the registration fee as indicated on the Financial Fact Sheet 2010-2011. Because the preschool payment options can be different from regular tuition, I further agree to pay all weekly preschool bills in a timely manner. I agree to have my account paid in full every two weeks, if paying by the week, and understand that failure to do so will result in my student(s) not being allowed to return the following week.
